**Police Property (Regulations) 1997**

**A report by the Chief Constable**

At the Police Authority meeting on 16 September 2003 Members agreed to delegate to the Chief Constable powers in relation to the disbursement of funds accrued from property coming into the possession of the police under:

The Police (Property) Act 1897  
The Powers of Criminal Courts Act 1973

The purpose of this report is to outline to members expenditure for the financial year 2005/06 based on the following criteria: -

The applicant/organisation must normally be Cumbria based, or benefit residents of Cumbria.

It must not be a commercial organisation.

There must be a bona fide 'charitable' objective.

There is an impact upon Community Safety and Crime Reduction.

The application contributes to the delivery of the Constabulary Youth Strategy.

It encourages contact and partnership with Local Policing Teams.

The desired outcomes can be easily measured.

To ensure donations are spread as widely as possible National or Countywide applicants will normally not exceed £500 and Area applicants will not normally exceed £250.

The donation is to assist the initiative/aim and is not intended as the primary source of funding.

During the financial year 27 applications were received.

Of these, two did not meet the criteria. Disbursements to the 25 approved applications amounted to £14,250.00
